# Manager's Report - Sam Floyd

Final December financial numbers show that the business is in good shape, and net income for the year is only \$191 below budget.

Sam stated that the projected January financial numbers are way down due to the unseasonably cold weather that we endured. We are down \$24,000 in revenue for January. Included in that figure is the \$7,000 we are down in F/B. Golf drives F/B income.

The Bush Hog mower is still down, however fortunately we really do not need it until the growing season arrives. One of the Sand Pro machines is down, they feel they can get by with one until it is repaired.

The air conditioner in the kitchen has died. It is the original that was installed in 1998. Sam gave numbers of approximately \$6,000 to repair and \$11,000 for a new one. Sam is going to some research and get back to us as to what he feels should be done.

The new beer cooler has been delivered and installed. The cost was \$2,100 and it is a new unit.

Sam said he had no problem with the seasonal member range proposal which was discussed at the last meeting.

Dick Sjogren made a motion seconded by Vince Laverghetta, it reads "Seasonal Equity Members will be allowed to purchase a six month range membership for \$90.00 plus tax for a single and \$120 plus tax for a couple. This will be billed monthly for the six months they are playing members." The motion was approved.

## Secretary – Dick Sjogren

Dick read an email from a member who felt that whenever a shotgun start was happening, other than a regular day, due to a large outside group, that an email should be sent to all members letting them know. It is the opinion of the board this would put an unnecessary burden on the pro-shop since the information is already on the monthly calendar posted on the wall by the restrooms. Dick said he would relay that information to the member.

During the discussion Vince explained that he was working to try and make outside groups feel as welcome as possible, since they are vital to our success, and not make them feel as if they are an imposition. He is looking at methods such as welcome signs to make them feel wanted. Another method mentioned was announcing the group before the horn and thanking them for coming.

Bob was absent, however he had prepared a report for the Board which was read by Dick Sjogren. He wants Sam to check on pricing for the turf reinforcement mesh called TurfProtecta for entrances and exits on some of the cart paths. Together with Terry Stephenson and Sam he will identify which paths we will target. Once identified, these areas will be prepped however the actual installation cannot be done until the start of the growing season.

Bob would like to get together with Linda Gietz to contact Green Isle Gardens in Groveland. Hopefully we can get the gentleman that made the presentation to the garden club to come out and give us ideas and recommendations as to how we can improve the ravine on #16. If he can provide us with a feasible plan, Bob would form a committee and determine how to proceed.

Bob feels that an E-Blast should be sent out explaining that the course closings on Feb. 12<sup>th</sup> and 14<sup>th</sup>, at noon, to do the Pre-Emergent applications are to help take care of the goose grass. We should let them know we are covering a wider area on the holes to combat weeds both in the fairways and rough. It was pointed out that this closure information is on the golf calendar however people need to know how hard we are working to eradicate this weed.

Bob also pointed out that we had 2 days of heavy frost that should have helped kill the existing goose grass. The pre-emergent will provide a means to help keep it from spreading.
