BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. February 8, 2019

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in the Great Hall Meeting Room. Those present: Dick Sjogren, Vince Laverghetta, Bob Keating, Mike Russomano, Dave Kozlowski, Linda Gietz, Steve Ryan, Esther Patterson and Ann Carter. Craig Misch, Golf Pro, Linda Eaton, F/B, Crown & Shield, Sam Floyd, Par for the Course Management, and Terry Stephenson, Course Superintendent, were also in attendance

President – Dick Sjogren

Dick Sjogren called the meeting to order. The Minutes of the January 25, 2019 meeting were approved.

Superintendent's Report – Terry Stephenson

Tractor is still down; got one new deck in January; still working on them.

Putting on first pre-emergent on Monday and Tuesday – tees, fairways and roughs.

Sprayed first application for nematodes and fairy rings.

Fertilized greens with new fertilizer at a better price.

Spiked greens.

Repaired some of the valve boxes; edged and cleaned others.

Talked to Wesco about monitor issue (LED readout) on pump station; Sam researching a replacement monitor (new vs used).

Will investigate some of the greens that are thinned out where the seed got washed off. Will roll and paint greens for Member Guest tournament.

Put out old seed in driving range around the flags.

Put sand in some areas on fairways and entrances/exits of cart paths.

Spot spraying for broadleaf weeds.

May have to spray for poa annua control in areas in the next couple of weeks

No maintenance needed to the natural cedar finish of the Purple Martin birdhouse; will keep an eye on it to keep it looking good; not sure what happened to one of the "birds" on top of it!

Manager's Report – Sam Floyd

We took a hard hit in the Golf Department with rain & cold mornings. January 2019 had 8 days of inclement weather compared to January 2018 that had 14 days. Our total sales were down to budget by \$9,204, but if the F&B department hadn't exceeded their budgeted sales by \$4,232 it would have been a lot worse.

By controlling expenses, we were able to help lessen the effect on our Net Income to finish \$7,718 behind budget but exceed last January's actual by \$1,892.

• The Golf Department finished \$13,278 behind budget but beat last year by \$6,213. We were down to budget 411 total rounds and \$12,646 in Green Fees & Cart Fees. Our revenue per round was budgeted at \$25.22 per round, but made \$28.28 per round, which is great.

• Member dues were up \$524 only because of the "Rental Memberships". There are currently 15 members on Medical Leave, which affects our revenue.

• Pro Shop sales for January were down to budget \$966 but are ahead of budget year to date by \$469.

• Maintenance Department was under budget by \$1,738 due to only spending \$1,450 for tree removal with a budget of \$2,500 and we had a budget of \$700 for sand & gravel that we did not need to purchase at this time.

• Food & Beverage Sales were up \$4,233 to budget, and Variable Cost Profit was up \$3,518 which helped our total outcome. The Food & Beverage department is doing extremely well. It has been attracting new business from outside of the gates and private parties that help cover the sales that are affected by low golf rounds.

We did not perform very well in January for the above reasons, but we still have three months to make up any lost ground. We are currently \$6,427 behind our year to date budgeted Net Income.

Dick looked at total revenue and asked that Sam consider figuring the budget next year based on like weather conditions. Also, we need to continue to look at our golf fees/pricing to ensure we are competitive in our rate structure next year.

Sam reported on his research of a new phone system to replace the existing system that is 10 years old and the voice mail is not working. He received 3 bids and has chosen one that is within budget and works through our network rather than the phone company. It has unlimited voice mail, additional phone lines to accommodate the waitress station, the course superintendent, etc., and is blue tooth compatible. Network support is provided at a monthly fee between \$25 - \$35. System can be installed in March (rather than the June previous date). Linda Gietz made a motion seconded by Dave Kozlowski that we purchase a Grand Stream GPX 2135 phone system not to exceed \$3500. The Motion was approved.

Vice President – Dave Kozlowski

Dave reported that he had a meeting with Carol Smith of the "Monarch Patio Committee" (consisting of herself and Barb Bradford) to discuss the patio brick process. In that discussion, it was advised that the money collected is used to pay for projects the committee decides are worthy. Carol advised she would be happy to attend our next Board meeting to update the Board with their process and spending and would be glad to work with other committees if needed. The Board also discussed Mulligan Money expenditures, and maybe these two groups develop a purpose that matches our current and long-range plans.

Dave requested that the donation by a resident of Royal Highlands in memory of her friend be used to buy and install a tree across the ditch to the left of the hill on hole #16. Once Bob receives the funds to proceed, he will talk with Sam, Terry and JT's regarding what is involved (ie, drainage in #16 ravine), any disruptions in golf play (hole #16 will become a par 3 during this time), when is best to start (maybe the last week in April before aerification), how much it will cost, and bring this information to the next Board meeting.

Dave asked the Board's approval to investigate the support for memorial dates to be placed on bricks. Ann advised that when the brick project was started the decision was made that no dates be placed on the bricks.

Buildings and Grounds – Bob Keating

Bob fixed the stone wall on #9 and installed a 2x6 board and put the bricks back on top of that and it looks good. The bricks are changing color and starting to look bad due to the buildup of black mold. Bob treated them but they need power washed. Bob will get with Terry about using the spray rig and gas generator that operates the pressure washer.

Last year we put coquina at the entrance and exit ramps on 4-5 holes. We need another load on the ramps for holes 1,3, 5, 7 & 9. These holes have not had coquina put down. The cost is \$750/load. This is a non-budgeted item, but since Maintenance is under budget, we should have some funds available and now is the time to purchase it because the staff has available time to lay it since they are not able to mow. Dave Kozlowski made the motion seconded by Ann Carter made the motion that we spend \$750 on coquina to be used on exits and entrances ramps on cart paths. Motion passed.
