BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. February 26, 2021

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in Mtg Rm A at the Rec Center. Those present: Vince Laverghetta, Therese Buono, Bill Ortbals, Steve Ryan, Esther Patterson, Steve Bryan, Steve Snover, Jim Oddo. Absent: Lisa Ritchey, Craig Misch, General Manager and Lisa Applewhite F/B Manager, Crown & Shield. Terry Stephenson, Course Superintendent, was also in attendance.

Vince Laverghetta called the meeting to order. The Minutes of the February 12, 2021 meeting were approved.

Superintendent's Report – Terry Stephenson

- Field's Equipment is helping to sell the Bushhog.
- We are sending parts off old pump station to Radwell International for them to buy.
- Spraying poa annua and other weeds around course.
- Will be spraying 2nd application for fairy ring and nematode control on greens.
- Looking for an assist and 2 other golf course employees.
- Mike's Tree Service came out to quote on tree work.
- Advance Electric came out to quote on electric for fountain on #3 pond.
- One of our employees who works in our Maintenance Dept as a Grounds Keeper is still in the hospital. Ann Carter has volunteered to collect monies to help with expenses. She will be sending out an email to all members with more information, including the link to the Go Fund Me page.

Manager's Report - Craig Misch

January Recap

Golf Department, green fees/cart fees were up \$816 to budget and up \$4556 to last year's sales. Member dues were up \$4307 to budget and up \$5380 to last year. Our membership is growing!! Expenses in golf were down \$6778 to budget and down \$6167 to last year, the main reason is the GHIN handicap bill came in January last year but will not hit our reports until February this year. Driving range expenses were up because of repairs to the picker cart and six cases of brand-new range balls.

Food and Beverage Department, sales were up \$1144 to budget but down \$481 to last year's sales. Expenses were down \$2474 to budget and down \$4542 to last year.

Course Maintenance department, expenses were up \$12577 over budget, this was an anticipated overage due to several factors, the two most significant factors were the down payment we made on the new equipment package, and Pre emerge billing hitting a month earlier than normal. Overall, as a business our revenue was up an extraordinary amount because of the PPP loan/interest forgiveness hitting the income sheet. Taking that out of the equation, total revenue was \$175,390 up \$5301 to budget and up \$8320 to last year. Expenses were up \$8109 to budget and up \$10,930 to last year. I took out the interest income number on the income statement of 130,253 to get my figures on monthly revenue.

Maintenance Road Repaving – Craig continues to follow-up regularly with DAB about the maintenance road.

Treasurer's Report – Steve Ryan

Linda Gietz, Financial Manager, attended the meeting and expressed concern over major capital expenditures until 2023 when our mortgage with BB&T is due for renegotiation. Vince Laverghetta responded that the clubhouse renovation committee is reviewing numerous ideas for improvements to our clubhouse, including expansion of the bar area. The committee will present their recommendations to the board for their consideration before June 30, 2021. The board with the assistance of the renovation committee will prioritize the line items of the recommendations and approve those items that are financially feasible. The board is cognizant of our responsibility for the financial stability of the club.

Clubhouse Restoration Update from meeting on 2/23/21:

- Dave, Lisa, and Vince met with Evergreen Construction to discuss extending the bar area out and/or putting in a service window to the outside patio. Estimates provided to the board.
- Tom met with K&A Construction about the men's restroom remodel. The estimate of work time was upwards of three weeks. They said they could do double shifts to cut the number of days down. They also have a flooring division, so they took measurements to give us a bid on carpet tiles.
- Carolyn got two estimates from Cepra for redoing the landscaping in front of the clubhouse
 with plants that would provide a variety of colors. We are looking at using live plants in the
 pots on the front porch with drip systems to them. The bids include a drip system and using
 mulch or rock.
- Dave is looking to freshen up the porch 3 new lights, paint for the floor and ceiling, replace the mats at the entrance and the bar area.
- Lisa, Carolyn, Regina and Sue will go to Sherwin Williams to look at paint. We are leaning towards a color palette similar to the Rec Center, greys and whites.
- We will also meet with Floors of Distinction, an architect and another carpet vendor next month.

Jim advised that last year we did a handicap study to ensure scores are being reported and reported properly. Marketing – Steve Snover

Steve scheduled a phone call with Dylan Smith of Golf Life Navigators during our board meeting to answer any questions we may have for him and his website. We decided that this is something that would benefit a real estate company more than the golf club. We will table this idea until Steve has an opportunity to talk with several real estate agencies who sell within our community to see if they are interested to partner with us in this venture.

Building and Grounds Report – Steve Bryan

Project List Update:

- Directional and Info Blue Signs Complete
- Beverage Cart (used): Steve advised the beverage cart for \$8500 plus shipping is located in Augusta, GA. We also discussed using the new Cushman and buying an insert which would cost about \$2,000. It was decided that Steve should look for a used beverage cart closer to our location.

- Replace fountain on hole #3 Terry Stephenson met with Advance Electric who will provide us with a quote on the electricity for fountain.
- Tree Trimming Met with Mike's Tree Service for estimate on tree trimming:
 - ➤ 15 trees: #12 tee 3 trees left side and 1 tree right side, #13 tee 5 trees left side, #6 tee 6 trees left side. It will take approximately 2 to 3 days to complete the job with 4-5 guys to be done in 2 weeks. Price: \$5225 and Terry's staff will haul away debris.
 - ➤ 3 trees on golf course front right side of #12 green. It will take 1 day to complete the job with 4-5 guys and can be done the first week of May. Price \$2275 and Terry's staff will haul away debris.

Steve Bryan made the motion, seconded by Steve Snover, that we trim 18 trees on the golf course in an amount not to exceed \$8000. Motion approved.

Steve received a letter from a member with an offer to replace the broken cart path at the 9th tee, the 10th green and the 14th tee and pay for the concrete and labor. The golf course would need to break up and remove the broken cart paths concrete in those three spots, cut out the roots that have made this problem, and also place two (2) 2x4s on each side of the cart path to hold in place the new concrete. This work would need to be completed by next week, which coincides with his verbal agreement with the contractor to replace his patio. This was discussed with Terry and determined that while this is a generous offer by a member to do this, it is not feasible for us to do it at this time. However, we do have some other solutions to fix these cart paths.
