# BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. March 8, 2019

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in the Great Hall Meeting Room. Those present: Dick Sjogren, Vince Laverghetta, Bob Keating, Mike Russomano, Dave Kozlowski, Linda Gietz, Esther Patterson, Ann Carter and Steve Ryan. Craig Misch, Golf Pro, Sam Floyd, Par for the Course Management, Terry Stephenson, Course Superintendent and Linda Eaton, F/B, Crown & Shield were also in attendance.

# President – Dick Sjogren

Dick Sjogren called the meeting to order.

The Minutes of the February 22, 2019 meeting were approved.

## Superintendent's Report – Terry Stephenson

Tractor transmission, brakes, rear end, hydraulics – bad. Will get a quote to determine cost of repair - if \$5,000-\$10,000, not worth it to repair.

Finished putting out pre-emergent on greens.

Sprayed second application of fairy ring control.

Put out insecticide for crickets.

Started coquina project – finished #1 and #3 so far.

Will paint handicap markers at Clubhouse next week.

Hole #16 Project: Talked to Dr Barry Troutman (turf and ornamental specialist) about location of Leyland Cyprus trees on #16. They need to be where overhead irrigation does not hit them; moved the location from top of the hill down a bit; need to be watered by hand for a while. Met with Cepra to get a quote for work on #16 (drain in the ditch and grass on top).

Wesco repaired pump station tubes chewed up by animals. Sprayed repellant on new tubes. Bayer company sending us some free product for us letting them do testing on driving range and #10 rough.

We are behind mowing/weed eating because we can't fill the vacancies we have.

We will rent a machine from Global Turf to pick up the leaves on the course.

### Manager's Report – Sam Floyd

Sam provided the preliminary financial statements from February. We took another hard hit in the Golf department with rain & cold mornings. February 2019 had 5 days of inclement weather compared to February 2018 that had 1 day. Our total sales were down to budget by \$6,915, F&B department beat budget by \$198 and the Golf department missed budget by \$7,115. Maintenance Department was under budget by \$4,788 mainly due to a credit we received from unused seed that Howard Fertilizer bought from us for \$2,012.67. This was due to Terry putting the word out that we had seed left over (33 bags) and he did not want it to sit there.

By controlling expenses and applying some credits that we were expecting, we were actually able to make up some lost ground in our Net Income. Our February total net income exceeded budget by \$3,313 which helped make up some of our shortfall to our year to date Net Income. We are currently \$6,805 behind our year to date budgeted Net Income. We are only behind budgeted Net Ordinary Income year to date by \$3,309 which is good considering the weather.

Pump monitor doesn't show where the problem is and cannot read the pressure levels. Sam will investigate other options.

## **Golf – Vince Laverghetta**

MWGA Beat the Pro Golf and Pizza party on March 7 was a great success. Eighteen teams have signed up to play Men's Match Play beginning March 11. Esther to provide Vince with the Women's Match Play schedule for posting on the Golf Calendar. Vince will talk to Amy about scheduling the date for next year's Member Guest Awards Banquet in the Great Hall.

Vince spoke to the GM of Sugar Mill Golf Club in New Smyrna Beach regarding their association with Golf Life Navigators. They feel the investment has paid for itself as they are getting about 2 memberships per year as a result of the link with GLN; and they are very pleased with their service levels. The Board is inclined to not get involved with this venture at this time.

Ann mentioned a website called "Group Golfer". It is a marketing strategy that provides a fast and easy method of putting a spotlight on your golf business, increasing awareness with the intent of guaranteeing new customers and generating revenue. It was determined that this was a type of "Groupon" deal, and one the Board is not interested in pursuing. Ann did mention to the Board the possibility of using Group Golfer later this year and was told to bring it up again during the summer.
