Manager's Report - Sam Floyd

Golf department revenue was up over budget due to the (5) five rental members and more members OFF medical leave which brought an additional \$3,536 in membership revenue. The increased Pro Shop sales of \$2,689 were derived from selling several Callaway drivers during the Demo Day and running specials.

F&B missed their budget sales for February by \$2,811 but made up some lost ground from January in their Variable Cost Profit. January year to date they were down (\$4,108) to budget and through February year to date they are now down (\$3,299) to budget, bringing \$809 more to the Variable Cost Profit line. They are doing a much better job controlling their payroll costs and overall expenses.

January year to date net income was behind budget (\$9,626). Through our continuing efforts and operating efficiencies, the year to date net income is now \$89 ahead of budget.

More cart path grinding will be done during the week of March 19th.

The men's section of the Member Guest is full, and there are 3 openings for the women.

Terry Stephenson gave an update on course conditions.

They have finished spraying for poa annua weeds.

They had a problem with one satellite for watering holes 1,2,3, and 9. They replaced the satellite with the one on 15 and were watering 15 by hand. They have gotten three new satellites so we now have backup.

Purchased 12 tons of 6,3,3 fertilizer to help the Bermuda come once it warms up again.

Took samples on 2 tees and 2 greens for nematodes but have not received results yet. We have the pesticide Indemnify to control nematodes.

One tee mower is down with engine problems. Decision on what to do will be made after Sam prices out repair versus replace. The replacement of two greens mowers is included in the long-range plan for 2018. When greens mowers are replaced the old mowers become tee mowers.
