BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. March 22, 2019

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in the Great Hall Meeting Room. Those present: Dick Sjogren, Vince Laverghetta, Bob Keating, Mike Russomano, Dave Kozlowski, Linda Gietz, Esther Patterson, Ann Carter and Steve Ryan. Craig Misch, Golf Pro, Sam Floyd, Par for the Course Management, Terry Stephenson, Course Superintendent and Linda Eaton, F/B, Crown & Shield were also in attendance.

President - Dick Sjogren

Dick Sjogren called the meeting to order.

The Minutes of the March 8, 2019 meeting were approved.

The next Informational Meeting for the membership will be held on Wednesday, April 17th at the Crown & Shield. Dick will send out the previous presentation to the Board for updates; Ann will send out an eblast to the members by April 8th.

Dick requested that anytime there is a member-only golf event that there be Happy Hour bar prices. Linda Eaton agreed.

Dick sent the Board a copy of a letter that Craig and Linda received from an outside golfing group thanking them for the wonderful golf experience and food service they received recently at the Monarch Golf course & Crown & Shield restaurant. They said the course was in great shape, how much they enjoyed playing here, and that numerous people said they planned to return on their own. Linda was especially thanked for helping to make the decision to change to a buffet and the food and service were both exceptional.

Superintendent's Report – Terry Stephenson

Working on the 3500 finish mower that now needs 2 mower decks; tractor will be sent out for repair.

Continued spraying beds for crickets.

Finished coquina on hole #10; used some coquina to firm up cart path on #9.

Spot spraying tees for weeds.

Painted handicap bumpers at parking lot.

Received a quote and scope of work from Cepra for work on #16; Sam gave a copy to Bob.

Terry to let Cepra know they can start as soon as possible. The hole will be played as a par 3 on the day the work is being done.

Still no luck hiring employees for maintenance.

Terry will talk to Josh about the impressions (rings) left around the cups on the greens.

The new flag poles are tight in the cup and sometimes the cup comes up with the flag; need to be careful when pulling the flag, which will loosen over time. Bought 2 extra poles for #4 and #16 –we will put them together.

Bayer company sent us \$5900 worth of free product for letting them do testing on driving range and #10 rough; some of this was for nematodes.

The white "bubbles" on the fairway were placed there to indicate the path for tracking the liquid fertilizer.

Next week will apply first application of nematode control on the greens and on the tees. Will fertilize tees next week and spray for weeds (poa annua control).

Manager's Report – Sam Floyd

Sam advised there were no changes to the preliminary financial figures in the report provided at the last Board meeting and it should be marked as Final. March doing extremely well; and we made up some lost ground in our Net Income. We will meet budget this month and should finish \$4500 ahead in revenue. We are currently \$6800 behind budgeted Net Income to date. Financially we are doing extremely well.

Sam reported on the pump station - he could not get one at a reasonable price and the monitor cannot be replaced because the system is too old. Terry suggested we just work with what we have and even though you must get at the right angle to read it, it will work.

Member Guest Report – Craig Misch

Craig reported on the Member Guest Tournament coming up in April. We will meet or exceed our budgeted goals. He thanked Ann for doing a great job as Program and Ad Sponsor Chair, and mentioned Carolyn Case, Volunteer Chair, Michelle Penski, Hole Signs Chair, and Diane Christie, Door Prize Chair.

Buildings and Grounds – Bob Keating

Bob to work on spraying the beds on Wednesday using the tanks from Terry. Bob mentioned to Terry that the #9 gold tee box is very dry and almost down to the dirt. Terry found snails in the sprinkler head and fixed it. There were 9 heads on #16 that had snails in them that had to be fixed also.

Golf – Vince Laverghetta

Vince will put out a new Golf Calendar to include the Women's Match Play schedule. He added a Ringer Tournament on April 17 and a Beat the Pro Tournament/Luncheon on May 8 for the Men's Group.

Finance and Audit – Steve Ryan

Steve handed out to the Board a finance and audit packet containing a Contract & Agreement Summary for leases and agreements, a copy of the Golf Now agreement, a Depreciation Schedule, etc. Steve asked the Board to read and review for the next meeting.
