# BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. May 24, 2019

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in the Great Hall Meeting Room. ## President – Dick Sjogren

Dick Sjogren called the meeting to order.

The Minutes of the April 26, 2019 meeting were approved with the following correction: Dick Sjogren made a motion seconded by Vince Laverghetta to spend \$8935.96 for a Bad Boy Z-Turn Rebel Mower. Motion approved. The Minutes of the May 10, 2019 meeting were approved.

## Superintendent's Report – James Hopkins Jr (for Terry Stephenson)

The new tractor came last Thursday.

Will finish pre-emergence on greens this week.

Spot sprayed tees and greens for Nematodes.

Sprayed fungicide/insecticide on greens.

Dick and Terry talked and decided not to punch the fairways - the cost is \$7,000 and plugs are messy. Soil samples were taken and there is only about 2" of soil and underneath that is all clay. The slicer we have now can go 2" in depth, and the decision was made to aerify and start slicing roughs with existing attachment this week. In the Fall, we will put out an extra 75# of seed/acre (30% increase) and maybe do aerification in the Spring.

#### Manager's Report – Sam Floyd

The final report for April was received and total of all revenues were behind budget \$12,323. We are still tracking to make a profit this fiscal year. May net income is looking good. Preliminary results of Member Guest Tournament showed a profit of \$371.28. Craig to send Board the final results.

### Vice President - Dave Kozlowski

Dave met with Steve Ryan to discuss doing a zero inventory before yearend on maintenance equipment, kitchen equipment and pro shop to help with long range plans for inventory needs and tax liabilities. Sam advised that he already has a maintenance equipment inventory for Terry's department and will send to Dave copies of what has been done annually.

#### Question:

How can we justify having Craig Misch and three additional employees in the Pro Shop. It appears Ralph, Dina & Laura are there more than Craig is seen. In past years there has only been one alternate, now there are three. Is the Pro Shop that busy to justify that many employees?

#### **Answer**

Due to the structure, particularly on the days we have shot gun start and double tee starts, the Pro Shop requires more than one person. The three people are sharing the same number of hours as if we had one full time person and are temporary employees. Craig is working more than 40 hours. As a salaried employee, he does not get paid overtime.

# President – Dick Sjogren

Dick received another estimate (Proformance Roofing) on the roof which came in \$3,000 less than the previous estimate received, but the shingles are lesser quality. The roof was patched about 6 months ago, and Proformance said work shows this roof shouldn't be leaking. Sam suggested that we use a roofing engineer or insurance adjuster to inspect the roof and get an unbiased opinion on its condition for replacement. Board agreed and Sam will pursue this approach.

Ann reviewed the Board absences planned during the summer months due to vacations, and it was noted that we will not have a meeting on June 28 because we will not have a quorum. Dick advised that even though he will be away for the next 3 months, he will be available for Board meetings through conference calling.
