# Manager's Report

After reviewing several options and estimates, a decision has been reached for eliminating our irrigation pump/shaft problem. The original estimates for repair/replacing the shaft or shaft and pump varied from \$19,000 to \$8000 and could have taken up to two weeks to complete. The management team contacted Liebold (same company that did the greens irrigation

upgrade.) and the shaft will be replaced in one day (the pump is still good) at a cost of \$3,602. There will be some tree work required to allow a crane to raise the pump and shaft bringing the total cost to \$4602. This project will be done around the 28<sup>th</sup> of June.

A trap rake has been purchased for \$500.00 and has been modified to accept an attachment from the old one. This should help to keep weeds in waste areas under control.

Rain cancelled the mole cricket treatment and it will be done on the 18<sup>th</sup> of June when the next aerification will be done.

The crew trimmed trees and repaired washouts in bunkers instead on Monday.

The pallet of sod and truckload of coquina for repairing exits and entrances to cart paths will be purchased. The work will be done once the transition has occurred.

Larry Demaline is no longer leasing space in the cart barn.

May projections still look pretty good despite the poor weather.
