BOARD OF DIRECTORS MEETING MONARCH AT ROYAL HIGHLANDS, INC. JULY 13, 2018

A meeting of the Board of Directors for the Monarch at Royal Highlands, Inc. was held at 8:00 am in the Great Hall Meeting Room. Those present: Dick Sjogren, Mike Russomano, Ray Smith, Bob Keating, Vince Laverghetta and Dick Therrien. Linda Gietz, Ann Carter and Terry Neikirk were absent. Also in attendance were Linda Eaton F/B, Sam Floyd Par for the Course Management and Terry Stephenson Course Superintendent.

President – Terry Neikirk.

Terry Neikirk was absent Vice President Dick Therrien called the meeting to order. The Minutes for the June 22, 2018, meeting, were approved.

Treasurer's Report – Linda Gietz

No Report

Manager's Report

Sam stated that we did not have a very good June and gave the reasons. The weather did not affect rounds as much as it did our F&B revenues. Our improved course conditions (over last year's conditions) have helped attract groups and other additional outside rounds.

June as an overall combined business we missed the total revenue budget by only \$2,782 and our net income was below budget by \$8,020. This was due to lower than expected revenues in Food & Beverage and increased expenses in maintenance and F&B.

Our total year to date revenue is behind budget by \$7,052 and our net income has fell short of budget by \$9,747.

Our net income year to date budget was \$87,067 and we fell short of it by \$9,747.

Our expenses were up over budget in a couple of departments:

Repair & Maintenance DEPARTMENT:

- Payroll was up over budget \$1,407.
- Fuel was up over budget \$722.
- Chemical purchases were up over budget \$1,798.
- Fertilizer was up over budget \$771.
- Sand & Gravel was up over budget \$791.
- R&M Equipment was up over budget \$2,852.
- R&M Irrigation was up \$649.

These are necessary expenditures to maintain the quality level of the golf course and to continue improving our product.

Food & Beverage DEPARTMENT:

Most people do not like to get out in the rain to go out to eat. To give you an example of the number of customers/covers we had this June verses last June:

• F&B revenue was down to budget \$3,351 and was behind last June by \$1,593.

• F&B revenue is ahead of last year, year to date by \$1,214 but variable cost profit is up \$3,323 year to date over last year.

• F&B payroll was over budget by \$1,253 mainly due to vacation pay but should even out by year end. (Year to date F&B payroll including taxes is still \$3,990 below budget). Year to date variable cost profit is now behind budget \$5,506.

• We sold 23 more pizzas this year verses last June with a \$280 increase in pizza sales alone.

Our F&B Department is still doing well, and we continue to see new customers each day. We will continue our marketing efforts within the community and surrounding email customers to grow our business.

We are still trending to generate a net profit this year!

Terry Stephenson reported #7 cart path near the green will be the next place that will be repaired with coquina. After that #14 will be done.

They recently sprayed the Tee areas for nematodes, and our greens are in such good shape this summer in great part because of our nematode control program. The mole cricket spraying was completed on July 5th.

The grinder for sharpening the mower reels has not arrived yet, because it is being refurbished.

Spraying for goose grass will be done on Sunday.

They are mowing the entire course at least one time each week, even though maintenance is down one employee.

Membership – Mike Russomano

Mike had a question about dues being frozen after age 80 for Limited Equity Members. Dick Sjogren made a motion seconded by Mike Russomano: **"Dues are to be frozen for all members who have been equity members for the past 5 years and have reached the age of 80.**"

Dick Therrien made a motion seconded by Bob Keating: **"Table the previous motion until next meeting to get information necessary to make an informed decision".** The motion passed.
