Dick Sjogren called the meeting to order. The Minutes of the July 12, 2019 meeting were approved.

Superintendent's Report – Terry Stephenson

- One Workman Down.
- Started two new employees that are worthwhile. We are only short one now.
- Edged around roadsides.
- Sprayed Briskway on the greens (Fairy Ring Control)
- Spot Tested Tribute Total (Goose Grass control on #11 & #4 greens). Seems to be working and does not hurt the Bermuda grass so went back and sprayed #11, #4 & #3 greens last week. The Bermuda is growing in where the goose grass is being killed. This product keeps and new goose grass that may come up. Still going to spot spray for a while. When its seeding is when it can be transferred to other greens by tracking of the mowers and shoes.
- If we Dry Ject, which we did a few years ago, the cost is \$10,000 for doing all 18 holes. This may extend the greens. We may want to consider doing this again next year.
- Treated Carpet Grass (right of #16 green) with Celcius. Once he gets a dry day Terry will treat. He wants to be sure it won't wash away.
- Sprayed fairways with liquid fertilizer and Symphony this week. This product helps to hold the moisture on the greens.
- We will be aerifying greens next Monday (7/29)
- Catching up on weeding, edging areas
- Erosion behind #17 has been addressed.

Manager's Report - Sam Floyd

July financials look pretty good. Member dues down \$4900 to budget, \$5200 to last year. We will miss budget by \$6500 this month depending on the weather.

Vice President – Dave Kozlowski

Dave is working on ways to increase membership along with more benefits to be and continue to be an equity members. Dave, Steve and Linda met and came up with some thoughts.

- Member booking for restaurant— no charge NOTE Any member booking an event at the Crown & Shield does not get charged a room charge.
- Play other courses paying cart fees only-summer program only
 Craig has already made the following arrangements with PLANTATION:

\$18.00 reciprocal play

5 days advance notice Any member can play Either course can be chosen

The member MUST contact our Pro Shop to make the arrangements. Only the Monarch member gets the discount. Any other guests will pay the rack rate.

This program is from May to October.

Current benefits for equity membership has:

- Voting member
- 20% Pro Shop
- Quarterly guest plays for free
- Tee time advance
- Special range ball program

Dave is proposing Stalwart Club which is free to all equity members

The Board was interested in Dave's ideas and has asked him to work further on this and come back with more information. This program may be of interest to some people to sign up as an Equity Member and will not cost any additional money.

The Board discussed writing up a bio on Terry so that the members could appreciate how lucky we are to have him. Dave agreed to do an in-depth interview with Terry.

Buildings and Grounds – Bob Keating

Regarding the tree trimming on Royal St. George's lane and St. Andrews Arc.

Enviro Tree Service gave us quote \$2,200 to trim the trees along the road side. JT's quote was \$2,850. Sam was able to get JT to reduce the price and he too came in with \$2,200.

To rent a Lift, the cost is \$290-\$420 per day. Bob recommended to do the lift and believes this can be done in no more than 2 days. We will use volunteers that will use a hand chain saw. The debris will be taken by the maintenance shed. The thought is to work with 14' to 16' for the canopy. Safety procedures will be in force. Bob will gather the volunteers for this project. He is looking at doing this project the middle of August.

Sam has been asked to advise the CAM so the RHPOA knows what we will be doing.

Dave made the motion to rent a lift truck to take care of the tree trimming not to exceed \$1,300. This motion was seconded Bob Keating. Rental will be for three days. All in favor.

Bob is recommending to increase the budget land/tree trimming to from \$2500 to \$3500 to cover the mulch that is needed over the year.

Sponsors are needed for the various flower beds on the course, either **financially or physically**. If we can't get sponsors for the existing beds, we need to remove some of the flower beds because we do

not have the labor to maintain them. If someone wants to sponsor a bed, again financially or physically, they can get in touch Bob Keating. Blue & white are free drop areas. There is an existing labor cost that is due Kathy who has been helping Diane. Ann will pay the \$80 to Kathy out of the notary money. Kathy was instrumental in cleaning up the garden on #13 and putting down the lava rock (free for the rock) around the bathrooms on #13.

Here is the scenario of who is doing gardens on the course

- #1-Christie is taking care of 1 behind the tee boxes. Kathy, our gal, in the Maintenance Department did weed on 1 between cart path and green/gold tee box
- #2-Gietz-Weasner
- #3-Carter-Walden-Mizinski -the left of #2 green, behind #3 Black Tee Box— taking care of this financially
- #3- Christie the garden across from # 8 green
- #5-Krzyzanowski-Christie- Conrad pays for the mulch, Diane has trimmed all the bushes around the memorial and oversees mulch spreading.
- #5-Christie-taking care of 5 around bathrooms but is in need of weeding right now.
- #6-Patterson by green/gold tee box
- #7-Patterson -trying to keep oak trees down around catcus area
- #7-Christie-has been paying Kathy to do around green and gold tee boxes
- #9-Christie by road
- #9 Christie-Garden between 9 green and club house bushes were taken out, I planted the two red copper plants, but as of now it needs to be weeded and if we want to put lava rock in that and Kathy has enough left. The other two gardens behind the 9 green and cart barn are a mess and needs lots of manpower to clean it up. Was done last before MG.
- #10-Christie by road
- #11-Keith Patterson/Sass and others helped weed before MG and we spread the mulch. (Gene Sass is currently unable to care for this garden due to illnesses.
- #13-Christie-financially (reimbursed by Ann Carter)
- #15-Lawrenson-maintaining garden by the three palm trees financially
- #16-Brondyke-maintains garden behind the Silver Tee Box
- #17-Christie-by the road
- #17-**Talarek-**working on 17 by their house
- #18- **Christie** around the turn around by gold, black, tee boxes, and just cleaned out 18 between green and road.
- #18- Christie-Next to tee box was cleaned out by Kathy and will need it again soon.

Here are the golf holes that could use sponsors to take care of them either physically or financially: #1, #3, #5, #7 around green & gold tee boxes, #9 by the road, #9 between green & club house, #9 behind the green & cart barn, #10 by the road, #13 (nothing needs to be done now, but will later), #17 by the road, #18 around gold & black tee boxes & around the road & #18 next to the tee box.
