# BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. August 23, 2019

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in the Great Hall Meeting Room. Those present: Dick Sjogren (via video conference call), Vince Laverghetta, Esther Patterson, Mike Russomano, Ann Carter, Steve Ryan, Dave Kozlowski, Bob Keating and Linda Gietz. Sam Floyd, Par for the Course Management, Craig Misch, Golf Pro, Terry Stephenson, Course Superintendent and Linda Eaton, F/B, Crown & Shield were also in attendance.

# President – Dick Sjogren

Dick Sjogren called the meeting to order. The Minutes of the August 9, 2019 meeting were approved.

## Superintendent's Report – Terry Stephenson

- Kubota tractor (used for pulling the Bush hog) being repaired; should have back next week. The bill was \$2150 - our portion is about \$450; Global is covering the remainder.
- Sprayed putting green for goose grass last Sunday; only green sprayed to see results first.
- Sprayed beds for weeds; sprayed edges in fairways and tees.
- Received free nematode control from Bayer (\$1700 cost) and treated #12 Black Tee; will treat other tees and spot fairway areas.
- Wesco coming next week to test grounds in satellites for lightning strikes.
- Also, Wesco coming to look at PM pump at pump station (not working).
- We currently use Windows 7 (this controls the irrigation system) and as of January, Microsoft will not support this version. Sam is working on it.
- Bought new product for mature goose grass; going to treat next week. We need to stop treatments by end of September so Bermuda grass can start growing.

# **Buildings and Grounds – Bob Keating**

Once the bushes on #16 near the new trees are removed that area will look better.

Sam and Terry resolved the issue on #15 between two houses on the right before tee boxes that we were not mowing. Terry got it mowed and it met the homeowner's satisfaction.

Bob mentioned that courses were being closed in the Villages because of flooding due to diverting water from residential areas. Craig said he had a few new groups from the Villages and we currently run an ad every week in the Villages newspaper.

Dave brought up the subject of what would it take to make our course more enjoyable to play, and less difficult; for example, removing the bushes in front of tee boxes on #12, #13, #7, #5. The goal would be to make it more fun, allow for great scores, and still maintain its challenges for all levels of golfers, and not make it too easy. Bob and committee will look into - what areas? what equipment needed? what needs changed? when to do it?).

Bob's committee met to discuss the gardens on the golf course. Thanks to Ann, we now have a list identifying the approximately 23 gardens and names of sponsors who are maintaining most of them. There are several people volunteering to do one or more gardens and we would like to reduce that as much as we can. We are going to identify garden areas that are eye sores and either eliminate them all together or find a means to make them presentable. Some examples are the cactus garden on #7 between green and silver tee boxes, the hill behind #14 green, #16 tee area between gold and silver tees. The committee also put together criteria for maintaining the garden areas, and Bob will set up a meeting with the volunteers to review the guidelines.

Mike said the MMGA holds a raffle every week to raise funds for course improvements. The proposal to install cart ramps on the street crossings requires the approval of the RHPOA.

## Manager's Report – Sam Floyd

Sam recognized Bob Keating for the excellent job he did putting the group together for the tree trimming project. Kudos to Keith Patterson who supervised the use of the Lift equipment and provided his expertise on running it to make sure no one got hurt, and to John Buono who did all the sawing. Bob thanked all the volunteers (12 members and 1 non-member) for all their work and will send Ann a list of their names to put in newsletter. The job was complete in 5 hrs, and the total cost of the equipment was \$423.04.

Sam asked for a status on the Board decision's to add Esther to the checking account. Linda will get new signature cards and get with Dick when he returns to sign the corporate letter.

#### Food & Beverage – Linda Eaton

There was an incident with one of the pizzas (which was corrected), and Linda reiterated her policy that each pizza box is to be opened for review by the customer before it is handed out.
