## Manager's Report

The September forecast is that we will be \$2,500 short on income. This is due to golf revenue being down. Food and Beverage is having a good month. We expect to have net income of approximately \$5,000 for the year.

Expected net income for next year is \$28,671.

The Maintenance budget for next year is \$494,877.

## Terry Stephenson - Maintenance Supervisor

One tractor is still down. The problems with the transmission and hydraulics are worse than originally thought. The 3500 rough mower is down because the mower deck plates are bad. They are looking for a machine shop to fabricate the deck plates they need. New plates would be \$800 each and we need seven of them.

Fairways have been sprayed with pre-emergent for poa annua in preparation for over-seeding. Wednesday nine greens were sprayed for goose grass.

Fertilization is taking place every three days to help the repaired places on the greens. There has been \$2300 added to the maintenance budget to remove debris that has accumulated from tree and shrub trimming.

Maintenance is pre-ordering many of the chemical products for next year, which saves a considerable amount of money. Linda Gietz made a motion seconded by Vince Laverghetta to "Approve the maintenance early order budget amount of \$111,150." The motion passed.

Dick stated that Diane Christie has agreed to be the chairperson of the nominating committee for the upcoming Board election. Some names were suggested as possible members of the committee. They will be contacted.
