# BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. October 11, 2019

A meeting of the Board of Directors for The Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in the Great Hall Meeting Room. Those present: Dick Sjogren, Vince Laverghetta, Mike Russomano, Steve Ryan, Bob Keating, Linda Gietz and Ann Carter. Esther Patterson was absent. Craig Misch, Golf Pro, and Terry Stephenson, Course Superintendent, were also in attendance. Sam Floyd, Par for the Course Management, and Linda Eaton, F/B, Crown & Shield were absent.

# President - Dick Sjogren

Dick Sjogren called the meeting to order.

The Minutes of the September 27, 2019 meeting were approved.

## Superintendent's Report - Terry Stephenson

- Kubota tractor (used for pulling the Bush hog) still in shop (mechanic out M-W); one Greens mower down.
- Wesco came out Tuesday and fixed PM Pump.
- Met with Harrell's; finished up early order program.
- Out of 11 days, missing employees 10 days.
- Started spraying pre-emergent for Poa Annua.
- Spot spraying for weeds in roughs
- Got quotes from Wesco and Leibold on Grounding issues.
- Working on spreading out budget monthly,
- Sprayed Revolver/Provaunt on greens for Poa Annua.
- Oct 21 & 22 Put out Pre plant fertilizer on fairways, tees, greens
- Oct 24 will overseed greens and collars and approaches.
- Oct 28 will overseed fairways/tees/greens

## Manager's Report - Craig Misch

Total of all revenues were below budget \$13,510 but our total operating expenses were under budget by \$18,610 with some yearend prepaid insurance adjustments which is great!

- September the Golf Department revenue finished \$13,199 behind budget and was behind last year by \$22,134.
- We were behind budget by 727 total rounds; behind budget \$10,253 in Green Fees & Cart Fees. Remember that we were closed two days in September for the predicted Hurricane Dorian, which effected business four days. Our revenue per round was budgeted at \$21.70 per round, but we made \$22.76 per round, which is good for this time of year. The coupon ad is for 2 for \$51.99/\$25.99 per person.
- Membership dues were behind budget by \$3,386 for the month of September and behind year to date budget by \$11,839. This is mainly due to having members on medical leave and members dropping

their memberships. We finished the year \$24,746 behind last year's membership income. Again, I have always said that two reasons why you should always increase dues annually, even if it is only a 2% increase; it will help cover the normal increases of doing business and help cover lost membership revenue due to other members being out on medical leave.

- Pro Shop sales for September were up over budget by \$248 and only down \$1,218 to budget year to date.
- Golf department expenses were under budget by \$210 which was due to payroll cost savings.
- Maintenance Department was under budget by \$7,384 due to payroll, credits to fertilizer and chemicals from the EOP program and R&M equipment.
- Food & Beverage Sales were down \$652 to budget, but Variable Cost Profit was up \$177. Year to date variable cost profit is ahead of budget by \$12,207. The Crown & Shield has performed extremely well for 2018/2019!
- Food & Beverage expenses were under budget by \$1,391 due to payroll savings.
- Occupancy was under budgeted expenses by \$9,624 due to a yearend commercial/workers comp insurance prepaid expense credit, per our CPA.

We finished the year \$47,645 behind our year to date budgeted Net Income. We finished the year behind budgeted Net Ordinary Income year to date by \$36,966.

We are \$21,398 behind year to date last year's actual Net Income and \$5,704 behind year to date last year's actual Net Ordinary Income.

We did not make a <u>net</u> profit this fiscal year mainly due to weather, higher maintenance & operational costs and lower membership revenues collected.

### Vice President (open)

Position will remain open until the December election. Dick Therrien will help new Vice President with inventory but has no interest in being on the Board again.

The replacement of the restaurant carpet has been put on hold until approximately May, but we have information from 5 companies that will bid on it when the time comes.

#### **Buildings and Grounds – Bob Keating**

Craig will remind golfers using handicap flags to adhere to the policies we have in place. The Handicap flag policy will be posted on an eblast by Ann Carter.

We will rope off grass area around #13 green toward the bathroom so people will use cart path; and rope off area left of the bathroom toward #14 tee boxes so people will use cart path.

Craig presented a change in the rates of the current Village coupon to get more value out of it.

Craig is working with Benchcraft, a company who makes yardage booklets for golf courses. They are quite nice, full color diagrams of each hole individually with yardages on them. It is a free service for the Club because they sell advertising in the booklet to pay for the books. It will take about 4 months to complete the process of setting up the booklets before we get them. They will be free to anyone who plays at The Monarch. They will be a nice added benefit to our players.
