# BOARD OF DIRECTORS MEETING THE MONARCH AT ROYAL HIGHLANDS, INC. April 11, 2025

A meeting of the Board of Directors of the Monarch at Royal Highlands, Inc. was held at 8:00 a.m. in Mtg Rm A at the Rec Ctr. Those present: Rick Mason, Bonnie Rex (via phone), Harold Beasley, Tom Cvikota, Dean Woodle, Terry Pollard and Esther Patterson. Luis Colon, General Manager, Craig Shelton, Course Superintendent, and Dawn Catando, Food and Beverage Manager, were also in attendance. Bill Ortbals and Wendell McDannel were absent.

Rick Mason called the meeting to order and the minutes of the 3/14/2025 meeting were approved.

# **Course Superintendent – Craig Shelton**

Highlights:

- Sprayed greens with second application of insecticide for mole crickets. This is one of the most active times of years for mole cricket mating, so they are constantly flying in searching for mates.
- Sprayed greens with fertility and nutritionals
- Edging irrigation
- Sprayed 16 fairway for mole crickets
- Still spraying around course for broadleaf weeds
- Spraying weeds in waste areas
- Sprayed again for lubbers

# Notes:

- Green's aerification is scheduled for Monday the 28<sup>th</sup> of this month
- With cool nights and hot days turf is somewhat confused as to what to do. It tries to start waking up then cool nights move in and slow down spring growth. My main reason for referencing this is regarding goose grass on greens. Now that member guest is behind us, I will begin spraying greens again for goose; however, we need to make sure grass growth is sufficient to offset any herbicide damage.
- To promote green speed during member guest tournament I was maintaining greens on the drier side. In the past few days they have visibly dried down a little more than I wanted but they will be fine.

# Upcoming projects:

- We will once again begin smoothing out approach on hole # 6. Hurricane washed out all our work last time before grass was established.
- Continue sod work on bare areas around bunker edges
- Craig was asked about the white lines marking where the carts exit the fairway. He had delayed this project in an attempt to shift the location. Now that Member Guest is over, he plans to start painting them 2x/week but was asked to research the cost before proceeding.

# Rebuild Nursery/Test Green Project - \$21,173.96

Enlarge the green size from 2006 sq ft to 4500 sq ft

- Purchase 5000 sq ft of Tiff-dwarf Bermuda (\$8900)
- Purchase 178 tons of sand (\$8333.96)
- Rental Equipment: Skid Steer (\$3540) and Plate compactor (\$400)

Total cost includes tax and freight charges (does not include labor)

Need to start as soon as possible, probably next month.

# Rick Mason made the motion, seconded by Dean Woodle, to proceed with the Rebuild Nursery/Test Green Project in an amount not to exceed \$22,000.00. Motion approved.

The Board thanked Craig and his staff for the excellent job they did in preparing the course for the Member Guest tournament.

#### **Golf – Harold Beasley**

- Member Guest Harold thanked his committee, all the volunteers and Luis and his staff for the successful Member Guest tournament. He will schedule a meeting with the committee to go over the final results.
- The Golf Committee met to discuss an email received regarding a Black tee member driving to Hole #5 fairway to get to Hole #6 green during the Club Championship (in an effort to cut off the corner on the #6 fairway). This was advised to be a safety concern and tended to hold up play on #6 fairway. The committee

suggested that this course of action qualifies as "out of bounds" ... however, Luis advised that you cannot declare a general area OB per USGA rules. It was suggested that due to safety concerns, no one should cut the corner on hole #6 and if so, make sure someone from your group advises the players on hole #5 of your intent.

• The committee looked into a new golf tournament game called "Greens Keeper Revenge". It involves the course maintenance staff/greens keepers setting up obstacles on each hole (ie, no flag in the hole, a flag outside the green, the hole surrounded by obstacles, lost clubs littered on the fairway, obstacles on the tee box, push carts submerged in bunkers, etc.) The goal no longer is just about the score but enjoyment, laughter, and the occasional shared frustration. Harold discussed this with Craig, and he said it was a workable idea. The committee will work out the details and plans to include this in next year's calendar.
